Deborah is pleased that there is a Licensed Alcohol and Drug Counselor at the high school. Deborah mentioned curriculums, which can be incorporated in schools and she asked that they be given close attention.

Stacy Buckley offered an update that during the last teacher/workshop professional development day, nurses and guidance counselors got together to discuss the curriculum, what are we doing, and what can be done. They are taking inventory at the elementary schools to look at some things. There is time being dedicated to this and they are working with a doctor from Mid-State Health as a consultant.

Don Franklin commented that, "When we did the recent warrant article in Hebron the police chief suggested that he take time and other police as well, to work within the schools...there could be a coordination between the police department and school in their towns...something could be worked out with the current police officers."

Stacy Buckley added that there are programs to look into and it is a matter of evaluating them.
